



## The possibility to start a new Nuremberg judgment has been discussed in Moscow

The Rector of DonNTU Prof. K.N. Marenich took part at the international scientific and practical conference “Nuremberg Judgment – Historical Lessons and Modern Realities” which took place at the International Independent Ecological and Political University (IIEPU) on February 6-7<sup>th</sup>. The University and Donetsk National Technical University supported by the Russian Military-Historical Association, the Central Museum of the Great Patriotic War and expert association

Izborski Club were the conference organizers.

The Rector of the IIEPU Prof. S. Stepanov and Prof. K. Marenich were co-chairpersons of the Organizing Committee. Updating of the solutions of Nuremberg Judgment (1945-1946) confirmed by the General Assembly of the UNO on December 11<sup>th</sup> 1946 which assisted in development of the international laws as to suppression of crimes against peace and the mankind's safety was discussed at the conference. The issue is of paramount topicality now in connection with the NATO's barbaric aggression against Yugoslavia and tragic events on the territory of the Donetsk and Lugansk People's Republics.

Outstanding Russian scientists who are experts in history and sociology, politicians, academics, postgraduates and students, representatives of research communities of Moscow, Donetsk, Volgograd, Riga, Sevastopol, Belgrade and other cities took part at the conference.

There also was a press-conference where the results of the event were summed up. The Deputy Minister of Education and Science of the DPR Mr. M. Kushakov, the Rector of the IIEPU Prof. S. Stepanov, the Rector of DonNTU Prof. K. Marenich, the RF State Duma Deputy Mr. E. Fyodorov, and the DPR People's Council Deputy Mr. S. Rubin were among the participants of the press-conference.

**Prof. K. Marenich made his presentation called “A New Round of the Civilization Confrontation in the Perspective of the Events on the South-East of Ukraine”. The tenor is given below.**

The military tribunal in Nuremberg which took place in 1945-1946 was the act of the international censure of fascism being the ideological basis of aggressive wars and mass extermination of people. Hitler's regime, its punitive institutions, politicians and military figures of fascist Germany were found guilty in worst state crimes and those committed against humanity.

Monstrous crimes of the fascists and the Nazis had been made public initially and this allowed qualifying them at the corresponding legislation level and denouncing. Since then the concept of the

“Nuremberg Judgment” has been associated with unavoidability of punishment of the mass terror initiators who were champions of the idea of racial or national supremacy and genocide. Goodwill people consider it to be the act of reminding of danger of fascism renovation for the entire world.

One would think the horror and monstrosity of the crimes committed by ideologists of fascism and Nazism during World War II are so vivid that absolute inadmissibility of their returns is to be taken by the mankind by default. However, at the very beginning of the XXI century we come across the acts of state crimes, which are connected with those of the regime of the Third Reich and committed against the mankind, on the territory of Ukraine (one of the former republics of the USSR which suffered during the Great Patriotic War most of all). The issue of the necessity of international censure and fair punishment of the modern criminals who started the war and acts of aggression and genocide against their native people is in the agenda again.

There also is the necessity not only to rail at everyday's shelling of the peaceful population of the Donetsk and Lugansk People's Republics made by armed forces of Ukraine and other Ukrainian armed bands, but also to analyze the reasons that caused these tragic events.

Returning to the events which occurred 70 years ago it is to be mentioned that the Third Reich was looking for satisfaction because of its infamous defeat in the World War I. Its claims for the place under the sun concerned many countries with developed national economies. The Soviet Union was just a component in the claims fascist Germany entered.

The cold war and the current events make it doubt as to the possibility of Nuremberg judgment if fascist crimes had concerned the Soviet Union only. The confrontation between the Saxons and the Russian world lasts for many centuries and manifests itself with numerous conflicts and provocations. The contours of the future globalizing of the world economy were seen at the beginning of the XX century. Russia with its developing industry, stable and secured by gold currency, recognized and unbeaten achievements in culture and spirituality did not meet the plans of the world globalization puppeteers.

That is why drawing of Russia into the World War I, starting of state coups and a civil war in it, devastation with the real perspective of self-destruction are the links of one and the same chain. However, the strength of the Russian world is in the fact that the people oppose solidarity, strength of spirit, new leaders and heroes to the external crucial circumstances.

The Great Russia closed the free republics into the union within the shortest period of time under extremely hard conditions. It was an indisputable and outstanding event of the XX century. The devotion of the Soviet people resulted in unprecedented progress in development of economic potential of the state. That is why the idea of suppression of the Russian world turned out topical in the western community again. The World War II became another constituent component of the multi-age civilization confrontation.

The convincing victories of the Soviet Union at the fronts of the World War II and establishment of the anti-fascist coalition did not leave any positive hopes to the opponents of the Russian world in the 40s of the last century. That is why Dulles' plan is an innovation approach in the task of destruction of the Russian world through gradual degradation of the elites and big groups of the population of the USSR and at the post-Soviet territory.

Unfortunately, there are numerous examples of successful implementation of well-known clauses of the plan. The Soviet Union was made collapse without resistance of the people and powers that be. In 1991 the Russian world's cords that bind were cut. Millions of Russian people became emigrants without leaving their flats. Successful in the former times branches of the Soviet national economy were destroyed to please the western civilized community. A man of work was not respected any more. A successful consumer became the object of respect and imitation. Well-publicized and not always professional producers of cheap hits washed real values of Russian and Soviet culture out of the consciousness of the population. Even symbolic Soviet films were vulgarized by modern sequels of the same name. The descendants of the characters of bygone days were represented by exemplars with no morality who wore the uniform of Soviet officers.

The liberal community is united and organized as never in its life. It is it that represents the interest of apologists of the world globalization on the post-Soviet territory. The slogan “Our Motherland is in Danger” is topical again.

The events occurred in Ukraine during the last quarter of the century can be referred to the model of implementation of Dulles’ plan. Ukraine was the most developed industrial republic of the Soviet Union at the beginning of the 90s of the last century. It did not agree with the plans of globalization of the world economy, and more than that, it was an obvious competitor in a number of positions. The further pilfering of main funds, closing down of plants and branches proved that only Ukrainian people were interested in economic strength of the state. The elites that had lost touch with reality, had lived in their own worlds of euro and had integrated into America regarded the priorities of their own achievements and income as of paramount importance. It was not accidental that even minor success in renovation and development of the national economy of Ukraine ran into Kiev Maidan in 2003 and 2013.

The activity of the enemies of the Russian world planted into the soil of narrow-minded homestead values of an average Ukrainian and multiplied by inadmissible serenity of the Russian diplomatic corps in Ukraine made it possible to revive criminal ideas of Bandera’s nationalism and infect millions of people, especially youth, by them.

The experiment was a success. Even if the Bandera’s ideas had not been revived, any other idea able to unite masses of the population in the burst of Russophobic hysteria would have been started working on.

What happened in 2014? The Ukrainian elite (the members of which, by the way, were not the ethnic Ukrainians) which had sold itself to the West and had been coached by the West came into power. The idea of Euro integration worked as the catalyst in the case of making of anti-Russian aggressive and nationalistic zombies out of the population. As a result unbelievable things happened. The people who were born and brought up in the Russian ethnos and who spoke and thought in Russian started renouncing their Russian roots, history and culture and accepted fascist hanger-ons, gangsters and sadists united by the ideas of the UPA and the UNA-UNSO as their heroes. Along with unprecedented activation of the radicals the rest of the population of Ukraine remained silent in the hope of sitting snug in their homes as if the things which were taking place in their country had nothing to do with them. It is the population of historical Novorussia that raised an alarm and protested.

It is impossible to imagine the excitement and cynicism with which new Ukrainian government started ruining not only the industrial potential but the entire infrastructure of their own state dooming their citizens to hopelessness, lack of any prospect and poverty to please their American puppets.

The fact that the Donbass warfare started in Slavyansk is not accidental. It is the territory where the centre of the Yuzovski shale gas proven territory is. We should also take it into account that shale gas recovery modern technologies are connected with pollution of the environment with extremely dangerous chemical wastes. As a result, the territories turn into a desert useless to live at. Why to feel sorry for the resort town of Slavyansk the sanatoriums of which remember the tsar’s family and for Svyatogorsk ,the gem of Christianity which is very near the town, if the matter is in the shale gas deposit exploitation which the largest transnational companies headed by the USA Vice-President’s son are interested in?

No doubt the population of the territories would organize protest actions. But the American puppets that seized power in Kiev need the territories and the resources but not people especially as the population professes Russian culture and its own historical values which have nothing to do with Bandera’s ones.

That is why the aggression of Kiev’s junta against the population of the South-East in 2014 resulted in mass armed actions to send the population away of the historical territories. The shelling caused unbearable life conditions as life support objects such as filter plants, water passages, substations, hospitals and schools were ruined first of all. Large industrial and transport infrastructure objects were also shelled.

The fascists of the past could have envied the perfidy and mercilessness of the Ukrainian chastisers. The population of the shelled towns and villages left all their belongings and rushed to the Russian border in panic. The human beings who had formally the same citizenship and had sworn to defend lives and peace of their compatriots shelled and fired their cars on the way to the border. So it would be logic to think that it is Ukraine that renounced the people of Donbass.

It is to be mentioned that the Ukrainian community rushed to the field of Euro integration and forgot that by 2013 Europe had been present in Ukraine in many components. In 2012 Donetsk, Kiev, Lvov and Kharkov hosted the European Football Championship with triumph. The host cities were well prepared and the Europeans made themselves at home there. Besides the super-modern stadium Donetsk opened a new airport that met all modern requirements. How should we react on the action of Kiev authority when the airport was ruined by the massive air strike of the AF of Ukraine on May 26<sup>th</sup> 2014 (the next day after the elections)?

The steps followed the act can be called genocide of Ukrainian authorities with respect to the people living on the South-East who did not accept the ideology of Russophobia and that of Bandera.

The matter is in withdrawal of the bank system, industrial companies and plants, research institutions and universities from the territories of the Republics. Ukraine regularly blocked the delivery of food and medicines to the territory of the People's Republics and socially unprotected segments of people lost the Ukrainian state support. Kiev authorities bragged of making the children of the People's Republics spend time in wet basements instead of schools and kindergartens. The bragging was never at variance – they shelled towns. The shells of all systems of heavy artillery burst in the centre of Donetsk in 2014-2015. On August 14<sup>th</sup> 2014 the Ukrainian mockeries of soldiers shelled buildings of Donetsk National Technical University, the leader of the higher engineering education of Ukraine. The demand to transfer the universities from the territory of Donetsk to the areas controlled by Kiev without creation of the necessary infrastructure indicates complete indifference of Kiev authorities towards the quality of education in their country. It proves the thoughts that Kiev puppets of apologists of the world globalization implement their goal sets in this issue too. The world global system does not need strong Ukraine and thus educated Ukrainians. As to the Donbass population, the position of Kiev authorities is as follows: "yes" to the territory coming back; "yes" to the resource coming back; "no" to coming back of the pro-Russian population of Donbass. It is no coincidence that the nationalistic battalions promised to shoot the fighters in the towns and villages of Donbass and expel the native population from there and take away their accommodation and property.

So, who are aggressors and invaders? It was not us who came to their land. Our shells do not burst in Dnepropetrovsk, Kiev and Ternopol. It is us who have to defend with arms our right self-identity, history, culture and our mother tongue which is Russian. Kiev authorities sent their armed forces and Bandera's public media against their people and thus cut off and proscribed the entire population of the People's Republics of the South-East. Any time when we get information about new shelling of the AF of Ukraine, new damages and new victims we are sure that both the crime organizers and executers must answer for it.

It should be noted that the crimes of Kiev regime are obvious. Donbass announces it publicly. Russia is not tired of reminding of them at the highest level. However, "educated" Europe bursts into tears because of some killed cynics working for a French journal which is even not worth of speaking when the Ukrainian army and the punitive battalions shed the blood rivers of the peaceful population of Donbass.

The problem is that the current Kiev authorities serve the interest of the West and as a result is beyond the official criticism of the world pro-western community. On the contrary, the community nominated Russia to be the mankind's enemy, and the world anti-Russian establishment is getting more and more unceremonious trying to bring out the beast in the Russian bear and declaring with cynicism of its commitment to democracy values, respect of law and dignity of any person. The unwillingness to see obvious crimes of Kiev junta is an element of coordinated complex of measures the globalists take to withdraw Russia from the world political sphere.

Taking into account all above mentioned one automatically makes a conclusion that the current Kiev authorities are executors of the will of the world globalization tycoons and can fear the second Nuremberg judgment in the last instance. They would sooner be afraid of complaint of their European-American masters if they obey the guidelines improperly.

It should be admitted that that we are only at the beginning of another round of uncompromising confrontation of the Russian world and the western global doctrine. The truth is with us. So, we will win. The second Nuremberg judgment would be possible only in this case. Kiev organizers and executers of bloody crimes against Donbass people would be next to their masters- puppets on the dock.

### **International Scientific and Practical Conference is a New Step on the Way of Collaboration of DonNTU and the IIEPU (Moscow)**

The following problem blocks were examined at the conference:

- History of preparation and carrying out of the Nuremberg Judgment, unsolved problems and their aftereffects in the modern world;

- Development of the international institute of responsibility of legal persons for breaking of international standards of social safety; the principle of non-use of force in international relations and the right of self-defense;

- Historical and political evaluation of “humanitarian” intervention in the light of conflicts in Middle East, the Balkans and the post-Soviet area;

- Implementation of the UN General Assembly Resolutions. Struggle against making heroes out of the Nazis, neo-Nazis, racism escalation, race discrimination, xenophobia and intolerance connected with them.

The Head of the group of the LDPR in the State Duma, a member of the State Council of the State Duma Prof. V. Zhirinovski, and a Deputy of the State Duma of the RF Prof. E. Fyodorov took part at the opening ceremony of the conference. Prof. Zhirinovski said in his interview to the journalists of the TV channel REN-TV that the most terrible war, the civil one, was taking place in Ukraine. Hundreds of people died. The accurate number of the killed would be given only in some decades. He emphasized that Kiev had been able to solve the problem in a diplomatic way, but it had chosen the war.



Historians, sociologists, representatives of educational and research organizations from Russia, Serbia, the Donetsk People's Republic and the Lugansk People's Republic took part at the conference. The first Deputy Minister of Education and Science represented the DPR and Prof. K. Marenich- Donetsk National Technical University. 
# ПРОТИВ ЛИБЕРАЛИЗМА

A book of the modern French philosopher Alain Benoist ( born in 1943) describes the main principles of the European continental ideology in the centre of which are the values and traditions of European identity. The author criticizes liberalism, American hegemony and attempts of Washington to build the unipolar world. He supports Russian-European collaboration and states the main principles of the Fourth Political Theory.

**“Western Mainstream Media and the Ukraine Crisis”** by Oliver Boyd-Barrett (ex-master of the School of Media and Communications at the University of Bowling Green, Ohio, the USA, a current lecturer at California University). He is an author of several books, including the famous “Hollywood and the CIA: cinema, defense and subversion” (Routledge 2011).



He examines the western media stories on the crisis proximate cause and the roles of those who participated or somehow supported the demonstrations in 2013-2014 including the NGO supported by the USA and the right volunteer corps in order to destabilize democratically elected government of Mr. Yanukovich. The book studies the crisis in the context of fight for the power over Eurasia and Washington consensus. The author assesses the role of Russia and the ethnic Ukrainians in the Crimea, Odessa and Donbass and shows how the western mainstream media tried to do their best to demonize Mr. Putin. The book shows contradictions in the western stories as to the collapse of the Malaysian Flight MH17 in 2014 and proves the details of the Ukrainian air controller refusal to close the civil air space over the warfare territory. The author analyses the stories and defines the main principles of the western propaganda as to the conflict.

The book might be of interest for students and experts in media, communication research, and Russian and East-European policy. It has the following chapters:

## **Development of Collaboration with RU “BelSU”**



In August-December 2016 academics of the Department of Computer Modeling and Design Prof. Averin and Dr. Zvyagintseva visited Belgorod National University.

They delivered lectures to Master's students of the Institute of Engineering Technologies and Natural Science, did some research and prepared joint papers. They also developed methodological materials on the course “Object-Oriented Modeling”.

The academics wrote an application to get the grant of the Russian Fund of Fundamental Research for the project Theoretical Background of Points of Thermodynamics by the Methods of Differential Geometry of Multidimensional Space.

In December 2016 Prof. Averin visited Polotsk State University (Belarus) and delivered a course of lectures in topical problems of system dynamics and multidimensional analysis of data. He also signed a collaboration agreement between the Faculty of Computer Science and Technologies of DonNTU and the Faculty of Information Technologies of Polotsk State University. All this displays the interest of the hosts to develop research links with DonNTU and prospects of collaboration between the universities.

## **Collaboration with St. Petersburg Polytechnic University named after Peter the Great**

In autumn 2016 Prof. Skobtsov was invited to visit St. Petersburg Polytechnic University named after Peter the Great (SPbPU) to deliver lectures and organize classes within the frameworks of the Russian program 5-100-2020 and the collaboration agreement between DonNTU and SpbPU.

Besides Prof. Skobtsov developed a new course of lectures called “Evolution and Swarm Robotics”, carried out scientific seminars in evolution computations, and attended lectures and classes of Russian colleagues to exchange experience. He noted excellent laboratory base of the Department of Telematics that hosts Russian Contest in Robotics and collaborates with western companies in information technologies.

Prof. Skobtsov answered many questions on the Donetsk People’s Republic, Donetsk National Technical University, and its research potential and possible forms of collaboration.



## **Visit of Dr. S. Khrapko to Moscow**

Dr. S. Khrapko visited the company Advanced Technology Systems (Lyubertsy, Moscow Region) in October-December 2016.

He developed algorithms and software to control steel out-of-furnace treatment, program and technical complex to connect and process signals of equipment state and distance control of the path of bulk material and interaction with an operator.

The results showed that practical experience of the researchers of DonNTU will be in demand despite the warfare period.

### International Collaboration in Persons Victor Ivanovich Kalashnikov



Professor Victor Ivanovich Kalashnikov graduated from Donetsk National Technical University in 1967 and got a degree in electric drive and industrial plant automation. He worked at the university and had his postgraduate course at the University of Magdeburg in 1970-1973.

He, Prof. Tessmer, the Head of the Industrial Department of the Siemens Company, and Prof. F. Palis, the Honoured Doctor of DonNTU, the Head of the Department of Electric Drive of the University of Magdeburg, took part in the establishment of the German Engineering Faculty (GEF) of DonNTU. Prof. Kalashnikov was its first Dean.

The operation of the GEF was based on many-year experience of collaboration between DonNTU and the University of Otto-von-Guericke (Magdeburg) and the German company Siemens.

The GEF combines fundamental training at the university and practical application of the world science and engineering.

Bachelor's students study German and Master's students study English. Speciality training is in German and literature in the language and German technologies are used. The GEF laboratories are equipped with the modern facilities of the Siemens Company. The curricula are coordinated with the programs of the Universities of Magdeburg and Dresden which provides wide integration of the GEF into the German system of special education. Academics from Germany took part in training and the best students have their incorporated study at the University of Magdeburg.

The graduates of the GEF are well-trained engineers who have good commands in German and English and thus can work for joint and foreign companies.

They can be employed at the plants of the Donetsk People's Republic and Europe and be well-paid and have a high level of social protection. The economy of the Republic has reserves of high-skill work force and know-how transfer of advanced technologies to modernize the plants of our Republic.

The contribution of Prof. Kalashnikov into the development of the GEF and DonNTU is remarkable. **So, we are the “Vatniks”, aren't we?**
